## PRESIDENT'S REPORT January – December 2003

Dear Member:

It is my great honour to serve as President of Society of Registered Financial Planners Limited. Since its inception, the Society has been seeking affiliation with different international professional bodies to provide members with international recognition. In August 2003, the Society signed a reciprocal agreement with Institute of Financial Accountants (IFA). IFA was established in 1916 and is the oldest body of non Chartered Accountants in the world. this reciprocal arrangement, members of the Society can gain access to a UK professional body with worldwide recognition. Locally, the Society signed a reciprocal agreement in December 2003 with Institute of Crisis and Risk Management.

My tenure as the President of the Society was both exciting and challenging. 2003 was a terrible year for our domestic economy and unemployment was the most visible problem. Obviously we have to focus on our strengths. Hong Kong is the world's ninth biggest exporter of services. People in Hong Kong are applying skill and expertise, creating value, and selling that value to international customers and in particular to China. With the timely support of the Central Government such as CEPA, the individual travel scheme and the promise to buy our government bonds, Hong Kong's economy has begun to pick up. Productivity Council. This program is designed for practicing financial planners as those who

intend to pursue a career in financial planning. A graduation ceremony was held on 14 March

2003 at the Hong Kong Bankers Club to celebrate the achievements of our 1st graduating class.

On 28 December 2003, the Society set another milestone in its relatively young history. The first

Chinese program was officially launched in collaboration with the Orchard College of Shanghai

Jiao Tong University.

In 2003, the Society successfully organized the first ever industry award titled "Hong Kong

Financial Planner of the Year Award" for the financial planning professionals in Hong Kong. This

award has received strong support from eleven reputable organizations. The result was announced

Permanent Secretary for Financial Services and the Treasury, presented the awards to the winners.
